ANNOUNCEMENT POWER GENERATION FOR JUNE 2026

This announcement is made pursuant to Rule 13.09 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited and Inside Information Provisions under Part XIVA of the Securities and Futures Ordinance (Cap. 571, Laws of Hong Kong).

The power generation of China Longyuan Power Group Corporation Limited* (the “**C** **a** ”, together with its subsidiaries, collectively the “**G** ”) for June 2026 on a consolidated basis amounted to 5,348,794 MWh, representing a year-on-year decrease of 7.48% as compared with the corresponding period of 2025. During the month, the wind power generation registered a year-on-year decrease of 9.73%, and solar power generation registered a year-on-year decrease of 0.63%.

As of 30 June 2026, the cumulative power generation of the Company for 2026 amounted to 38,782,781 MWh, representing a year-on-year decrease of 2.19% as compared with the corresponding period of 2025, of which the wind power generation registered a year-on-year decrease of 6.67% and solar power generation registered a year-on-year increase of 22.22%.
